I, the undersigned, pledge

- not to use the customs' document in my country of residence or where I plan to settle,
- to export the vehicle from the country where the customs document has been stamped on entry at the latest on the day of its expiry,
- not to keep an imported vehicle in a country visited more than three months without permission from the local customs' authorities,
- not to take up salaried employment in a country into which I have imported a vehicle with customs' document without permission from the local customs' authorities,
- not to lend or transfer ownership of a vehicle imported into a country with a customs' document to person/persons residing in that country
- to contact the customs' authorities immediately if the vehicle for some reason cannot be returned to its country of registration, to respect local customs' formalities and to return the customs' document to M together with proof of its import into the country in question,
- not to de-register the vehicle from its country of registration while the vehicle is used in foreign countries,
- to return the customs' document to M as soon as possible after its expiry date,
- to authorise the M or other AIT/FIA-organisation to transport the vehicle back to its country of registration at my expense in order to prevent demands from foreign customs authorities,
- to pay customs'-, import- and other charges on demand immediately, if I have not complied with the above conditions,
- to compensate the M for damages and costs for which M can be charged by issuing me with this customs' document,
- and I promise that the trip, for which the M has issued a customs' document, is of a temporary nature and that I have no intention to settle abroad.
